Computer Science 15 seats for the session 2004-05 subject to fulfilment of the following conditions:-

1. All the conditions as prescribed by the State Govt. in the N.O.C. dated 12.7.04 will have to be followed and compliance report of fulfilment of all conditions will be submitted within 3 months.
2. No admissions beyond the number of seats allotted by the University will be made. In case admissions over and above the number of seats allotted are made, the University will not conduct the examinations of such students and the entire responsibility for the same will lie with the college authorities. It must be ensured that only eligible candidates are admitted. This should be adhered to strictly.
3. The college will follow and observe the University Act, Statutes, Ordinances, Regulations, Rules and Instructions framed and amended adopted and issued by the University from time to time.
4. The College will follow Curricula courses of study as prescribed by the University from time to time which will include scheme of examinations and conduct of examinations.
5. The college will appoint permanent and qualified Principal, and Teaching staff, Library staff, Sports staff, P.T.I. etc. on full time basis selected by duly constituted Selection committee as per norms of UGC and get the same approved from the University.
6. Building- Construction of building as per the guide lines of the University with provisions of play ground and hostel buildings.
7. Library- Year-wise purchase of books for library and sufficient provisions will be made for purchase of journals, magazines.
8. Endowment fund: Endowment fund as provided in the University rules will be created and University will be informed accordingly.
9. Atleast two faculty members in each subject will be appointed as per the decision of the academic council and Board of management which has already been circulated to Principal of all the affiliated colleges of the University.
