- No admissions beyond the number of seats allotted by the University will be made. In case admissions over and above the number of seats allotted are made, the University will not conduct the examination of such students and the entire responsibility for the same will lie with the college authorities. This should be adhered to strictly. Non-compliance will lead to strict action against the college which may include disaffiliation.
- The College will follow and observe the University Act, Statutes, Ordinances, Regulations, Rules and Instructions framed and amended adopted and issued by the University from time to time.
- The College will follow curricula Courses of Study as prescribed by the University from time to time, which will include Scheme of Examinations and conduct of examinations.
- The college will appoint permanent and qualified Principal and teaching staff, sports staff, P.TI etc. on full time basis selected by duly constituted Selection Committee as per University Act and norms of U.G.C. and get the same approved from the University and intimate the University within two months.
- Building-Construction of building as per the guidelines of the University with provisions of play ground and hostel building.
- Library- Year wise purchases of books for Library and sufficient provisions will be made for purchase of journals, magazines.
- Endowment Fund: Endowment fund as provided in the University rules will be created and University will be informed accordingly. Compliance of this point may be reported within one month of issue of affiliation letter.
- At least two faculty members in each subject will be appointed as per the decision of the Academic Council and Board of Management, which has already been circulated to Principals of all the affiliated colleges of the University.

- To provide the information as asked for by the University from time to time including Statistics etc.
- (a) Number of admissions will be restricted to the number of seats allotted by the University. No admission over and above the number of seats allotted will be made.
- (b) No admissions may be given in the subject(s)/course(s) without obtaining the affiliation in the subject(s)/course(s) concerned.
